Professionalism

- Recognizes ethical issues in practice and is able to discuss, analyzes, and manage common ethical situations. May be able to Analyze and manage ethical issues in complicated or challenging situations.
- Develops a mutually agreeable care plan in context of conflicting physician and patient values and believes
- o Displays sensitivity and responsiveness toward all patient populations
- Practice based learning and improvement
 - o Selects appropriate evidence-based information tool to answer specific questions
